4. Matters arising from the minutes:

9 (a) Playing Field

The signs had not been collected as no cheque had been signed for payment. Councillor M. Carroll agreed to inspect the equipment. The Clerk to contact Cornwallis regarding permission to purchase of a new litter bin for the play area.

There was no agenda but a general discussion as to the role of the Community Council in regard to the maintenance of the playing field, etc. It was pointed out that the council was obliged to get three different quotes and could not just accept the Cornwallis estimate of money required. Cornwallis agreed to submit a formal funding application.

Following advice received from One Voice Wales the Cornwallis Trustees would need to apply to Carmarthenshire County Councils Standards Committee for dispensation when discussing funding for Cornwallis. Trustees at all times work in the interests of the Charity. They enclosed a copy of the legal topic note on Basic Charity Law which explains the point in more depth.
